Each day we strive to bring hope and healing to our community; your contribution has made it possible for us to succeed in fulfilling our mission.

Every dollar makes an impact! Through your generosity, we are reminded that much can be accomplished when we work together. Below are just a few milestones from 2021 made possible by your generous gifts:

- Establishment of the Catherine Yardley Center of Pulmonary Excellence. This donation provides necessary funding for Holy Cross to conduct comprehensive research, advance clinically effective treatments of COPD and other lung diseases; spark the creation of a new lab focused on research and education; and allow for several enhancements to already established bronchoscopy labs.
- The Holy Cross Family Health Center was created to be the preeminent provider of education, prevention, early intervention, wrap-a-round social and mental health services and treatment of primary care and infectious disease services through innovative approaches that will make a real difference in the lives of others. Donations from The Jim Moran Foundation helped with the buildout of this center, while Ann Dana Kusch Foundation and Jeffrey Kusch supported the ability to bring the Ryan White HIV/AIDS Program to Broward County. This program provides a comprehensive system of HIV primary medical care, essential support services, and medications for low-income people with HIV.
- Holy Cross is now able to see more patients and apply early intervention through the growth and formation of The Salah Foundation Heart Failure Clinic. Our goal is to reduce hospitalizations and increase preventative care by providing intensive personalized therapy programs that help patients manage their disease.
- The COVID-19 Vaccine Clinic filled the community needs quickly during the onset of the pandemic, when other healthcare providers could not. Holy Cross was the first healthcare system in Florida to offer vaccinations to any healthcare worker and continued to protect those in our local community. We continue to focus on our mission to serve patients in their greatest needs.
- The Wanda and James M. Moran, Jr. Foundation and the Amaturio Foundation provided the needed upgrades to the Phil Smith Neuroscience Institute ALS Clinic and the Dorothy Mangurian Comprehensive Women's Center. Supporters of Holy Cross such as the Ayers Family and Millsaps Family aided in equipment upgrades and continued education and training for our clinicians.

These are only some of the milestones made possible through your philanthropy.

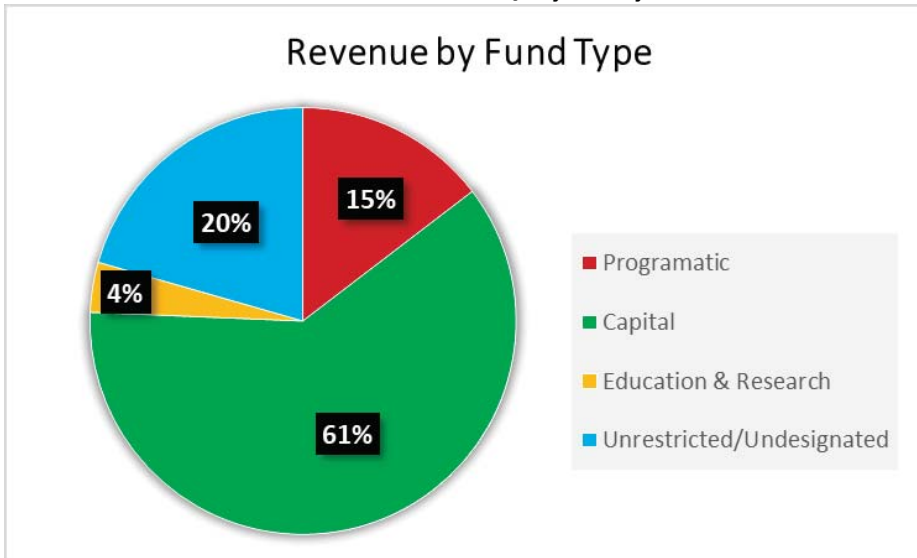

Total funds raised at Holy Cross Health in 2021

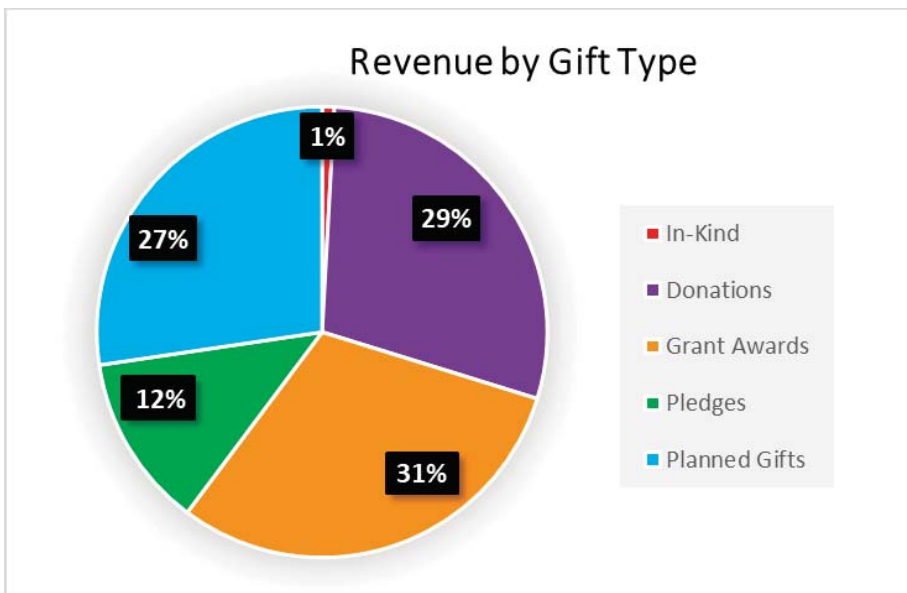

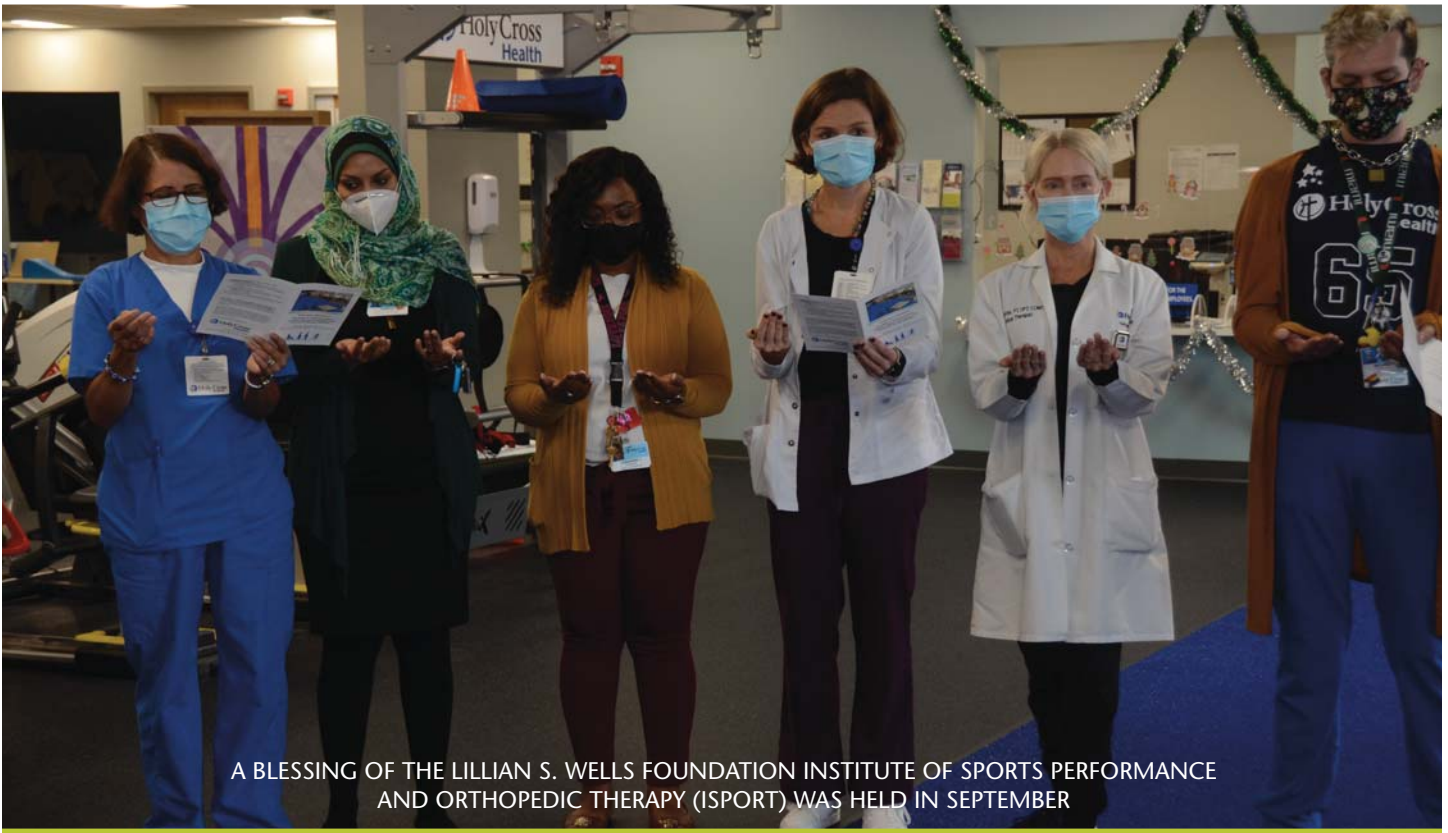
